Please be advised that this firm represents Dina Mackney, individually, as Administrator of the Estate of Christopher Hines Machnij a/k/a Christopher Hines Mackney (the "Estate") and as mother of minor children [REDACTED] and [REDACTED] Mackney (hereinafter, the "Minor Children"). Ms. Mackney, individually and as Administrator of the Estate, is the owner of the copyrights in the following works (the "Works"):

1. Copyright in the Photograph of Decedent depicted in the enclosed printout (owner: Ms. Mackney, individually); and
2. Copyright in Suicide Note of Christopher Mackney (the "Note") (owner: Ms. Mackney, Administrator of the Estate).

It has come to Ms. Mackney's attention that the domain name avoiceformen.com provides access to materials that infringe the Estate's copyright in the Work. The URL at which the infringing materials are accessible is: <http://forums.avoiceformen.com/showthread.php?8219-A-Father-s-Suicide-Note>. The information found at the offending URL also provides a link to a Third Party web site (<http://henrymakow.com/2014/02/a-fath....DCKrk6IV.dpuf>) which further infringes the copyrights of the Estate and the Minor Children.

We have a good faith belief that the use of the Work in the manner described in this letter is not authorized by, Ms. Mackney, the Estate, any agent of Ms. Mackney or the Estate or any applicable law. The information in this notification is accurate. We swear under penalty of perjury that we are authorized to act on behalf of Ms. Mackney and the Estate with respect to the subject matter of this letter.

Additionally, the website's publication of the Note contains extremely private information that constitutes invasion of privacy and publication of defamatory allegations. As Administrator of the Estate, Ms. Mackney requests that you take steps to remove the Note and any and all related material at once. This usage exploits not only this tragic event, but the safety and privacy of the Minor Children by identifying the age and county where the Minor Children reside for purely advertising purposes in an attempt to draw views to the website. The use of the Note and decedent's name is not authorized by the Estate nor is the use of the Minor Children's names authorized by Ms. Mackney.

We therefore request that you remove or disable access to the infringing materials as set forth in Section 512(c)(1)(C) and Section 512(d)(3) of the Act and pursuant to the Terms of Service of avoiceformen.com. Please contact the undersigned no later than seven (7) days from the date of this letter to confirm that the infringing materials have been removed or access disabled. The undersigned may be contacted at the address, telephone number, and email address set forth above. For your reference we are also enclosing a copy of the Certificate of Qualification for Ms. Mackney as Administrator of the Estate and the March 14, 2014 Order entered by the Arlington County Circuit Court, Virginia specifically authorizing and empowering Ms. Mackney with the legal authority to take all steps to remove offending material such as that present at the site referenced above.

First Comment by Phil -

Henry, Chris Mackney's suicide note and all that surrounds his situation is probably the most upsetting exhibit you have presented on the men's rights issue. I am originally from Northern Virginia and know Chris's type very well: this area produces some of the most highly educated, earnest, and ambitious people in the country, and I can just see from his face exactly the kind of man he was.

Yet for all the critical thinking skills and upstanding morals that his upbringing instilled, Chris had a fatal blind spot regarding women that has damaged so many millions of men and their children over the past several decades. Whether it is the traditional male initiation that Richard Rohr discusses in "Adam's Return" or some other more modern teaching of how to sever our addiction to female praise while navigating life in a feminized society, clearly a new school must emerge because not all men will simply "go their own way."

3 That they may do evil with both hands earnestly, the prince asketh, and the judge asketh for a reward; and the great man, he uttereth his mischievous desire: so they wrap it up.

Recipe to destroy family which you've spelled out so many times Henry;

Womyn to seek 1)Power, 2) government to fill the gap of father/husbandry, 3) their general "cost" of this is sexual immorality (porn, prostitution, multiple lovers, harlotry) protected by tax payer funded birth control/abortions.

Ray said (February 5, 2014):

I am a pacifist!

But if someone try to bring me to a point of suicide, then I'll suicide him/her/them first!

Melissa said (February 4, 2014):

I feel great sadness that this father chose to take his own life versus seek the face of the one true Hope. What a legacy he could have left his children should he have chosen life, and not a legacy of the spirit of murder. A true spirit that will manifest itself as a curse in which his children will need to address in their ongoing lives.

With that said, I can relate to his pain. I can relate to wanting to commit suicide. I can relate to the attempt of suicide. I can relate because my husband went through similar circumstances regarding his two children and their mother. My step-children are currently 20 and 18 years old respectively.

I have been a part of their lives for over 10 years. I was privy to a front row seat in their ongoing battles which stemmed from unresolved bitterness and anger between mom and dad. For years, I was appalled at how the family law court would side with the mom at the expense of the children and father. Loads and loads of money was spent not only in attorney and court fees throughout those 10 years, but in child support given to mom (state max of \$1500/month for the two children).

We would sit by and watch mom squander this monthly money away for herself and demand more from our household. We watched her demand the court liquidize a separate "bonus" account which was initially set up for emergency needs and/or college expenses. My husband went above and beyond monthly child support and put 10% of his bonus money into this account.

At a time in which he ventured out with two other men to start a business, and his monthly and annual income decreased dramatically with zero bonus income, his ex-wife went against her

agreement and took him to court for arrears of said account plus to liquidize what was in the account for her own purposes.

My husband could have petitioned the court to amend the divorce decree during that time, but he did not. He felt he could come to agreement with his ex-wife.

As the kids approached their teen years, so many truths came out about mom. The kids needed dad to fight for them. As of a few years ago, when they were approximately 16 and 14 years ago, the court awarded my husband full custody with mom having supervised visitation.

She now pays us minimal child support. The story is long as to how we reached that glorious situation, but my point being "hang on!" Fathers, the court is not in your favor. But Yahweh the Lord is. That is the only answer for you and for your children.

Al Thompson said (February 4, 2014):

I'm sorry to hear that this man committed suicide but the existing court system is not fit to exist. They are full of liars, thieves, and outright thugs and I also blame the stinkin cops who enforce these horrible orders.

Remember, when you go into court: the judge is your enemy, the prosecutor is your enemy, and your lawyer is your enemy spy. One is always better off not to have an attorney. Most people who help themselves have a better chance in getting a favorable outcome.

Lawyers love to drain the resources from both sides and then abandon the wreckage. The court system is satanic and it is best to stay out of it. If you catch a case, then start learning some legal procedure and handle the case yourself.

Lawyers, and I mean all lawyers will try to screw you and won't even buy you dinner.

L said (February 4, 2014):

The story about the man destroyed by Parental Alienation and the court systems touched me at the deepest level. You see my husband was the child in such a remarkably similar situation. Even at time when women had not become so crafty at manipulating the system, his mother did so. A pioneer at it. And as a pathological narcissist, turned him into an emotionally impotent and damaged human being, who resents women and is timid of men.

His own father was so defeated he decided to give up on my husband and start a new life. He eventually drank himself to death in grief over the loss of his son, but did enjoy for many years a good marriage to someone who loved him.

Suicide is cowardly, no matter how defeated one is. It leaves the children feeling abandoned, and they will now know his side of the story only from what is written. Who knows during these children's teen years if they would have needed him-an escape from the pathological mother who will no doubt do them harm. And now that option has been taken from them.

He is not the victim here, the children are.

Kristine said (February 4, 2014):

Hi Henry, take a look at that little girl's right hand - forming the 666. She is even glancing at a person standing out of view to get a head's up that she is performing correctly.

Wade said (February 4, 2014):

As a man who has been through two ugly divorces...both with children involved, I can say that when I read this mans suicide note...I understood what he was saying and feeling.

The family law courts are a joke...and the joke is on the fathers and the children who desperately need many really great fathers who are neutered, and removed from their children's lives, by this corrupt system. Financially ruined, separated from their children, and thoroughly abused by the system many fathers see no hope.

The results of the abuse this man withstood are described accurately in his suicide note. I can personally attest to all his descriptions of abuse...not only abuse against him but the most painful abuse fathers endure in the family court system is the abuse against their children. The courts and the mothers and their attorney's use the children as weapons with complete malice of forethought.

In the heart of many women involved in divorce and the family court system it is all about money and completely destroying their former husband and the father of their children. These women have no mercy or natural concern or affection for their children or their own lost integrity. God will judge them, their attorneys, and the judges involved.

There are, of course, exceptions to every general rule. There are certainly good mothers and bad fathers out there, but this mans experience is very, very, typical. Was he right to take his own life...of course not, but before you condemn him you need to walk a mile in his shoes.


