FOR MEN" with chalk. Keltner stated after writing on the sidewalk Gerard took pictures of the writing and pictures of the people standing around looking at the writing.

Keltner stated she fears for her safety and the safety of her family and colleagues.

Keltner stated she has seen the cartoons, video and blogs online and believes Gerard demonstrates having violent fantasies about hurting and murdering women. Keltner also believes Gerard is interested in challenging/silencing all women and gender programs and educational activities on campus. Keltner stated as the coordinator of gender and women's studies she is a prime target. Prior to the completion of the interview Keltner asked me if she should resign her position with Interdisciplinary Studies.

I told to Keltner about the buddy system and security escorts provided by the KSU Police Department. I explained to Keltner that the KSU Police Department Criminal Investigations Unit was aware of Gerard and his organization.

A security escort was provided for Keltner to her vehicle.
