Hi Robbie,

Just tried calling again, and hopefully we'll get a chance to chat at some point. I fully agree, and we absolutely want to have all behaviors documented that either cause disruption or are threatening. Part of the challenge thus far is that his behavior has been more "odd/awkward" then directly threatening, at least based on what the police and legal affairs have indicated. Actions absolutely matter, and we definitely need detailed documentation explaining what the actions are that were threatening. Unfortunately most of what we've received over the past months focus on how he makes people feel uncomfortable, and that gets translated by the individual perceiving this into not being safe.

Please understand nobody is trying to take sides or defend inappropriate behavior, but we also cannot expose the university to a potential lawsuit by overreacting if the behavior does not meet the necessary requirements for action. We get lots of cases where students are aggressive and rude, and we have no problem discussing our expectations for civil discourse with them, but unfortunately those standards are considered "aspirational" not binding by law or policy (as we all learned from the lawsuit that Georgia Tech lost years ago resulting in all of us needing to change any language about civility in policies).

We will hold any student fully accountable when we get appropriate documentation demonstrating a violation occurred, so I look forward to seeing the documentation from the faculty and staff. Filing police reports is important, especially for accusations of criminal activity, but do know that if what is reported does not meet the necessary legal threshold the police will not do anything, but the same information might still meet the threshold for a campus violation and we can take action. It all will come down to what is in the report (and employees can choose to report to the police, to me, or to both).

Hi Robbie,

I left you a voicemail earlier, and I'm running between meetings but should be around my office from 11-3 today. My direct line in the office is (or the new version).

I did hear from the police that Stacy is planning to submit a report and hopefully we'll get more details from that. As you know we've continually monitored this situation but unless a policy or law is broken our options remain limited, and students, or the public for that matter, have a right to know what books exist in our depts if they are "public" resources. The manner in which the information is shared can be controlled, for example, an open records request could be submitted as opposed to someone just walking in and

taking pictures, but there is no legal prohibition to someone walking in and taking pictures so insisting on the open records request vs. just letting someone know what books are housed in a dept may not be worth the trouble. Private books within a faculty's office are a different story, but as we both know the challenge is not what the student asks but often how he asks.

The key when dealing with difficult students requesting appts is for the person (or persons) meeting with the student to try and assess the purpose in advance and keep control of the meeting and content.

Hope we can chat soon.
